# Dreams Guidelines

The Dreams from the Hardt Committee has established the following guidelines to help applicants develop their Dreams and assist in making them a reality. Please don't hesitate to contact a Committee member with questions or assistance!

1. Applications, whenever possible, should be submitted by a Dream Team that includes the individual requesting the Dream, and members who will help support the actualization of the Dream, such as the Service Coordinator, Team Leader, and/or the Regional Manager.
2. Upon submission, the applicant and his/her Team will receive confirmation the Dream application has been received.\*
3. An interview with the applicant will be arranged to gather supplemental information.
4. Dreams from the Hardt has a limited pool of resources and cannot fund some Dreams in their entirety. The Committee uses a guideline of up to \$500 for any one Dream. If the cost to fund the Dream exceeds that amount, the applicant's team should submit details about funding the remainder of the cost.
5. The Dream application should include how the Dream will be accomplished, a budget that includes projected costs, information about service support, and how additional funds will be raised if costs exceed the Dreams donation. If needed, the Dreams from the Hardt Committee can assist you in compiling this information.

\* The Committee can't guarantee every Dream will be fulfilled.
